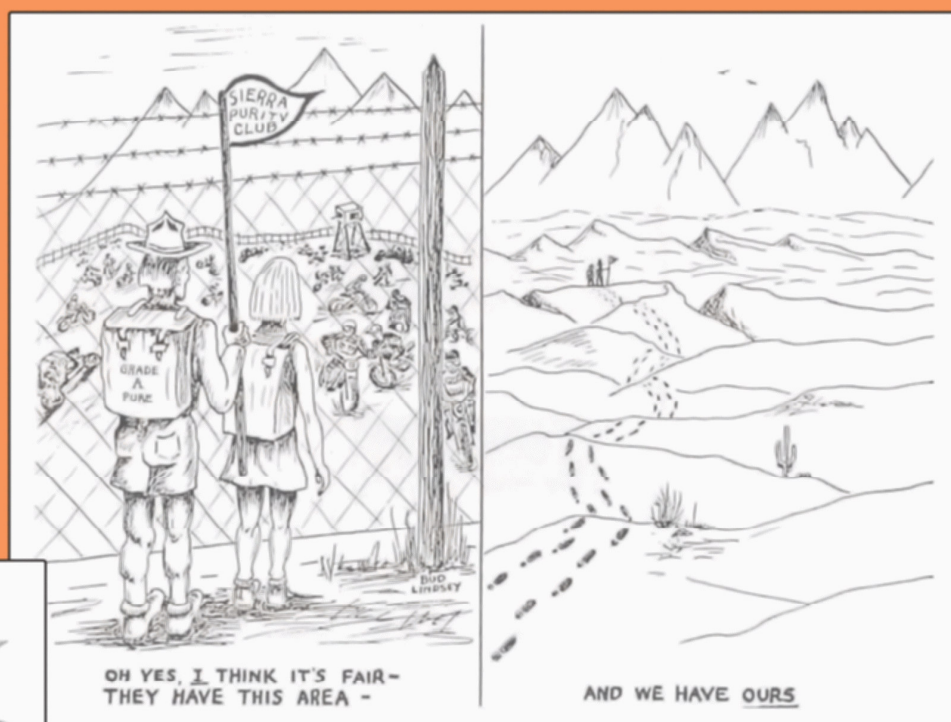

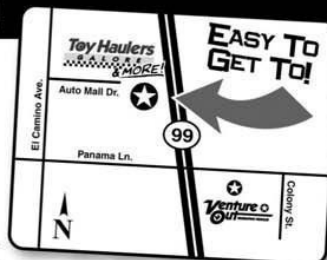

# WHAT IS CORVA?

The California Off Road Vehicle Association (CORVA) is a varied group of outdoor recreationalists who are extremely active in promoting the positive aspects of vehicular access on public lands and protecting that right.

The group is composed of the owners of "Green Sticker" vehicles such as ATV's, motorcycles, 3-wheelers, trials bikes, and dune buggies, as well as "street-legal" 4X4 vehicles, dual sport motorcycles, bajos and desert racers.

The main purpose of CORVA is to work with the land managers for responsible off-highway vehicular access and recreation opportunities. Secondly, we educate our membership on the constantly changing rules and regulations and promote conservation, clean-up and trail maintenance projects.

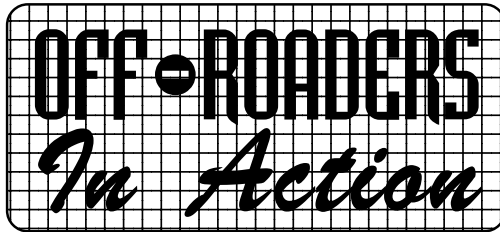
We are very active in the political arena and pay for a lobbyist in Sacramento. We work closely with the State Department of Parks and Recreation providing input to the Off-Highway Motor Vehicle Recreation (OHMVR) Program from the users' standpoint. We provide a valuable resource to land managers in the form of dedicated OHV enthusiasts who believe in responsible vehicular access.

A portion of the budgets for California's national forests and the public lands administered by the BLM is funded by grants from the Green Sticker Program. We work with the land managers to formulate the grants and give our input about the grants to the OHMVR Program which administers them. We also review how effectively our Green Sticker money was used in each program.

We are active at all levels of the land management public process with both the BLM and USFS. We do this by commenting on environmental documents on as many issues as possible and maintaining close relationships with personnel in the field as well as the staff.

We coordinate with other multiple use organizations ranging from snow-mobiles to horse enthusiasts to protect multiple-use rights from the environmental extremists. **We are "dedicated to protecting our lands for the people, not from the people."**

## Make the Best of the Post-Election Results *Get Involved*

Well, we have finished with this year's election and a lot of our members and other off-road organizations' members volunteered to work on the elections of their choice. We congratulate those of you who have taken the time to put effort into helping the candidates of your choice get elected.

As you all know, we are part of a group of off-road organizations that is called CLORV, California League Off Road Voters. This group sent out questionnaires to all candidates, both state and federal, to get their input on their position on off-road issues, backcountry travel and natural resources.

When the result of these questionnaires came back, we shared with you in the CLORV OHV Voter Guide those candidates that had a positive statement about off-roading. This is the simplest way for you

to understand where a candidate stands on off-road issues. Are there other issues a candidate has to deal with, of course there is. However, that is your choice, and your responsibility, to find out how a candidate stands on other issues such as fiscal responsibility, social services, transportation, abortion, etc. to make an overall determination of the candidate's competence.

Some say that is a narrow view of a candidate. Perhaps you are correct, but the off-road organizations are here to help us preserve our riding areas, and that started with our elected officials.

Now some may say it was a bad election. Others may say it was OK. Everyone is correct in this statement. Changes do occur, but off-road activities know no boundaries. It crosses all political

parties. It is not Republican or Democratic. It is our opportunity to go off-roading that we want to protect.

So what are we — you, me and everyone who rides — going to do from now on? Are you going to help us meet your local, state and national legislators? Many are new to office and need to hear from us before they get indoctrinated by the anti-groups. Will you now realize that without getting involved on a legislative basis you could lose it all? Will you now realize that volunteers in your favorite riding areas have done MORE than they should ever be expected to do and need a brake?

Trust me, I have written articles as CORVA President every month for 13 years. How much longer do you expect to keep

## Don't Fence Me Out - Part 2

California City located in the high desert, you may think the land of open spaces, but parcel by parcel, this is coming to a slow end. Between developers and our own government, the land of open spaces may be something we can only tell our grandchildren about as a bedtime story.

After a recent battle with California Department of Fish and Game (CDFG) over fencing a huge parcel of land that was a traded off to Hyundai Motor Corp. as a mitigation measure for Hyundai's building of a Proving Ground (a.k.a. test track) — another huge chunk of public land was lost to the rest of the public. "How this land was lost?" you may ask. After a long process, I won't bore you with the details here [But for

those who missed it, the background story can be found in, the October 2006 "Off Roaders In Action" newsletter page 4.], it came down to a final meeting on August 17, 2006 in California City.

The morning of the gathering, the CDFG, Hyundai Attorney Nick Browning, Hyundai consultant Jack Stewart and California City representatives met before the "official" meeting.

CORVA members Ed Waldheim and Wayne Nosala, Senator Ashburn's Representative Rex Moen and Ron Schiller chairman of the High Desert Multiple-Use Coalition came as a united front and together represented the desert communities and recreationists.

Representing CDFG was Julie Vance and Steve Juarez, both from Fresno. It was made clear that the public land that was

being fenced, was and I quote, "Our land". Not public land anymore, but land "Owned" by CDFG, (even though the deeds to the lands say State of California on them as I have a copy of them.) Both freely admitted that CDFG has not completed filing both California Environmental Quality Act (CEQA) and the Environmental Impact Report (EIR).

Since both these documents are required for their fencing project, then how do they not have to file them? Also, CDFG is spending time going after a small motorcycle racing promoter in the California City area for missing the exact same two reports that CDFG didn't file. This sounds like CDFG is beginning a power trip that is not at all the part of the mission statement written for CDFG. What is going on here?

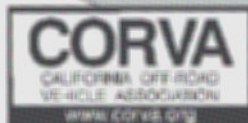

# Helping Youth

## Beach Play Day – A Day of Fun for At-Risk Youth

Our annual attendance at the California Police Activities League (CAL-PALS) event was attended by OHV organizations, CORVA, D-37, and San Diego Off Road Coalition. This was again a successful event that was accomplished on July 25 to 27, 2006 in Huntington Beach, CA. Cal-Pals is an organization that assists at-risk youth by helping them participate in all types of recreation, including off road riding. They do OHV training throughout California with police officers that are certified by ASI.

This year's event, (the portion that we were involved with and assisted in) was lead by Steve Yamaichi, from the State OHV Division, along with a representative from each SVRA (State Vehicular Recreation Area) in California. On August 9, 2006 he sent each organization a thank you letter stating, "I have also received numerous compliments from Departmental employees, volunteers and Daphne Greene, Deputy Director OHMVR Division, on how well the Off Road Adventure event was run. The success of this year's Off Road Adventure is directly attributed to the hard work and team effort made by all volunteers and Division Staff".

Why do I feel this event is so important to you the reader? Well, Harold Soens, who recently died from a massive heart attack, was instrumental in getting the kids involved in this program to get a chance to ride quads. Yes, as he would say "It is all about Kids." He dedicated his life to kids, from training them, showing them proper use of trails and equipment, including his grand kids. We all miss Harold, and this year's work was dedicated to him by the team members who attended this event.

During the day, our schedule was organized so as to have over 300 kids from Cal-Pals rotate through the 5 stations that were set up. The kids would rotate events every 20 minutes. When they came to us, they were outfitted with coveralls, socks, boots, and then the ASI instructors would tell them how to ride. The day before the event, Dave & Midge Swoger, Bud Schick and Fred Small of Los Aventureros, a CORVA Club, helped staff set up the hay bales all over the area on the beach for the perimeter, so that the riding took place inside of this area.

In total, 600 kids participated in the CAL-Pals Beach Days event, but due to age only 300 were allowed to ride the OHV course.

During the day we kept the track smooth. With rakes and shovels, we took out the tracks that wheels would make; yes it was hard labor for those of us who manned those hand tools, but to see the faces of all the riders was worth it.

We also did a lot of talking with OHV Deputy Director Daphne Greene who came down from Sacramento for the first time since we have participated in this event. We

also spoke with Russ Ehnes from NOHVCC (The National Off Highway Vehicle Conservation Council), Paul Slavic former employee of American Honda, and Greg Mumm the Executive Director for Blue Ribbon Coalition. They were all there to see what we were doing.

Steve Yamaichi kept the food coming so there was no reason to leave or rest on this work day! When it was all done, all 600 kids were fed by In-and-Out Burger. Executive Director for Cal-Pals, Ron Exley,



said this was one of the smoothest events he has had.

The event finished the last day with a breakfast for everyone, something that Harold Soens was always in charge of. This year CORVA Past-President Dave Swoger, Midge, Bud, and Fred were right in the middle of getting this breakfast accomplished.

A big thanks goes to all the volunteers, and remember next year on July 24 is Set Up Day, with Work Day on July 25, 2007. Breakfast and wrap up was on July 26, 2007 at Huntington Beach. We need to have a lot more volunteers next year

## Making Oceano Cleaner for Generations to Come

Oceano Dunes SVRA has become a favorite recreational area for thousands of off-road enthusiasts. Approximately 2.1 million people visit this 5.5 mile stretch of coast annually making it the busiest State Vehicular Recreation Area in California. On a busy summer weekend, its population will exceed 80,000 people. Unfortunately, not all that is brought in goes out. Items left behind become not only an eye-sore but often times a safety hazard.

FoOD has planned quarterly Clean Beaches Events. We are encouraging individuals and off-road groups to join us in the effort to make Oceano cleaner for generations to come.

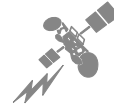

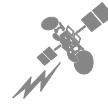

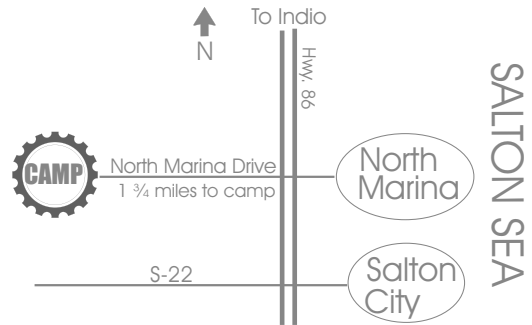

# Victory!

## Clear Creek Lawsuit Dismissed

HOLLISTER, CA (August 22, 2006) — Off-highway vehicle (OHV) recreation continues without the cloud of litigation at the popular Clear Creek Management Area (CCMA) for the first time in over eighteen months following the recent dismissal of a lawsuit brought by the Center for Biological Diversity (CBD) and California Native Plant Society. Managed by the Bureau of Land Management (BLM), the CCMA has been under attack for several years by anti-access groups seeking to close the popular off-road riding area, home of the AMA-sanctioned Quicksilver Enduro and known by enthusiasts throughout the country.

The BlueRibbon Coalition, a national non-profit recreation group (BRC), spearheaded an effort by motorized recreation interests to intervene in this

case in order to help to protect public access to the CCMA. The suit, filed in Federal District Court in San Jose in November, 2004, threatened to eliminate most motorized use of the entire area. The Plaintiffs filed numerous motions seeking immediate judicial imposition of travel restrictions, none of which were granted.

"We are pleased at this result. The recreation community is proud of its strong legal defense of the agency's planning process and continued support for active management of the CCMA," noted Paul Turcke, a Boise, Idaho, attorney representing the Salinas Ramblers Motorcycle Club, the American Motorcyclist Association District 36, the California Association of 4 Wheel Drive Clubs, the California Off Road Vehicle Association, the Off Road Business Association and the BlueRibbon Coalition in the lawsuit. "However, this success should not trigger complacency.

Before and during the lawsuit the Bureau of Land Management has been working on a travel management plan for the area. On January 13, 2006, the Bureau of Land Management (BLM) released its Record of Decision restricting vehicle travel in the CCMA to designated routes and areas. Based largely on the issuance of this plan, the Plaintiffs stipulated to dismissal of their suit, which the Court approved on August 3, 2006.

Don Amador, western representative for the BlueRibbon Coalition, states, "I believe that off-roaders should continue to build our partnership with the BLM and help support the agency's effort to have a balanced program. With the distraction of this lawsuit removed, the OHV community can even more sharply focus our resources on proactive management of Clear Creek."

At the meeting, it was suggested that part of the fencing corridor we sought [to keep the road bisecting the property open to riding & community traffic] we should pay a portion of the cost — well, actually a third of the cost \$6000.00, with California City picking up a third and Hyundai picking up the last third. Wayne Nosala highly objected to this stating that "CORVA is not a fencing company." Looking at the whole picture, we were being asked to pay for fencing public land with our donated money? Does that make any sense?

Not too much made sense at this meeting. Hyundai is spending hundreds of thousands of dollars for this fencing project. But don't feel too sorry for them — Hyundai looked into the fact that the American public has always objected to this type of land grab/fencing with extensive public notice. We know that off-road groups along with dozens of other multi-use groups would have put up a huge fight at the time this was being negotiated.

But, it's best to do this quietly and hope nobody notices, given that this was last minute notification. We, as the public, were basically told what will be and that is that. Oh, we did get a few small victories on the fencing. Some fencing moved a bit, but nothing that I would put my feet up and crack open a victory beer on.

The meeting concluded with Ed and his charming over the shoulder comment to Hyundai representatives, "I just bought a new car, I love it and it's a Toyota."

So there it is.

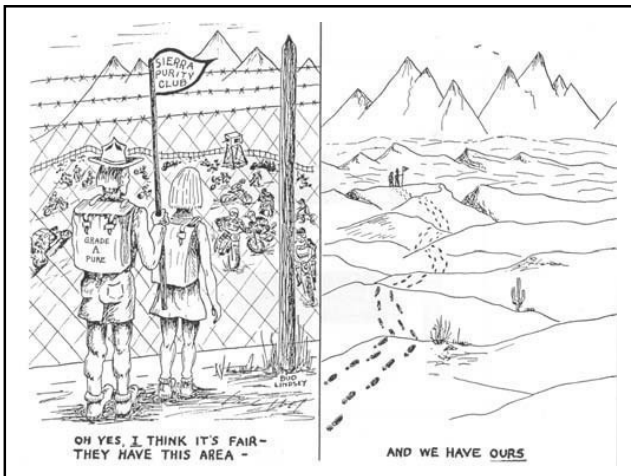
