The Governor's office was flooded with letters and messages well in advance of the latest budget deliberations. Thanks to all of you who responded, and thanks to Chris Horgan of "Save the Trails" for helping us mount an effective campaign. Let's all hope our Trust Fund is reserved for its intended purpose.

14th Annual Truckhaven Challenge A Success!

Well it is hard to believe that this was the 14th Truckhaven Challenge. The event started fourteen years ago when a few of us from American Buggy Association (ABA) got together and decided to put on a event to raise money and awareness for land use. In the beginning it was just named the ABA Truckhaven Poker Run and that year we had 13 registered vehicles! The event certainly has changed.

This year we were looking forward to returning to the Truckhaven location. But even though we had our permit in place, insurance in hand, toured the route with the biologists, and did every thing that was asked of us by the State Parks, we were forced to return to Ocotillo Wells SVRA. (A big thanks to Rick Fisher for working so hard with the State Reps.) Reluctantly we did as asked and wondered will people come?



One of the requirements for the event was that we take Plant Identification training so that a plant on the course could be marked and attendees aware of it locations. So during the week in addition to setting up our route, taking members of the State on a tour, we marked those plants that were on our course with Yellow Caution tape! While setting up the course, we have to ensure that all OHV vehicles can make the course. To do that, besides having a motorcycle or an ATV run the course with us, we setup the main route while running only in 2-wheel drive!

All this takes time and is the main reason that we start arriving on the Monday before the event to layout/mark the course, make changes and of course add the Green (hardest) routes! This year was one of our longest courses at 26 miles! That also had the longest Green route we have had in place. Of course, we could not have made these courses without the help of Travis Work, Steve Santa (sorry about the top), Vinnie Barbarino and his club members. Still, after a week of running the courses, making changes, sitting around campfires and having a great time, again we wondered would they come?

Slowly on Thursday night we noticed that

PRESIDENT'S MESSAGE

Loosing It All to Bureaucracy – the End of MiniBikes & Flagpoles

Once again the bureaucrats are regulating what we can and cannot do – this time concerning our children. As of February 10, 2009 you can no longer buy new small displacement motorcycles or ATV (quads) designed for children under the age of twelve. Motorcycle dealers, like me, are also no longer allowed to sell these, or certain parts to repair older small displacement vehicles – if the vehicles are primarily designed for young children. These vehicles, along with a multitude of other items, like toys and books, contain some components that contain Lead. The Consumer Product Safety Improvement Act (CPSIA) of 2008 regulates what can and cannot be sold or redistributed. Bureaucracy has gone crazy again and is interpreting into nonsense.

Surely, you know not to let your children chew on parts of your off-road vehicles, and also not to eat or chew on their own motorcycles or quads. But because the strict bureaucratic interpretation of the CPSIA Act regulates Lead exposure to children – and tire valvestems, engine cases, carburetors and battery terminals contain a certain amount of Lead – the act requires us to remove these items from anywhere our children might be. Strict environmental interpretation has now effectively eliminated an entire industry with the stroke of a pen.

Most off-road users learn their skills with their families when they are young - most definitely under the age of twelve. The future of off-road motorcycle and quad riding in America is now destined for extinction. All because we have discovered danger in a common element found everywhere on our planet. Science has taught us to use Lead with caution, and our own common sense should lead us to protect our children from over exposure. Sensible. Unfortunately, whenever the bureaucrats interpret common sense, the sense runs out the door.

Where does it stop? If we as parents still have the right to use our OHV vehicles and to raise our children, then we should also have ability to decide how we will teach them about poisons like Lead, anti-freeze and gasoline. OHV use while camping is a dramatically educational experience – about more than just the chance of danger from chemicals in our environment. Our children learn valuable skills, such as: meal planning, building safe camp fires, group safety, finding lost dogs, keeping close to camp (not getting lost), never riding alone, getting home before dark, staying out of mine shafts, helping each other when someone gets stuck or has a flat tire and depending on your preferences, they learn gun safety. By removing a parent's choice to purchase or maintain a small displacement vehicle designed specifically for your children, the bureaucrats have now forced you to do what they think is best for your child. And they have eliminated part of the method you might choose to do what you think is best for your child.

No, it won't stop with small motorcycles and quads. Bicycles are next; along with anything and everything your children use or come in contact with. Unless this insane interpretation is challenged – and challenged LOUDLY – nothing will be left. You must also recognize that there is also the danger in some children wanting to try the adult versions (bigger motorcycles and quads) which will cause more danger, and even the adult models may be outlawed (for their Lead content of course...)

A phone call, fax or letter to your Senators and Representatives in Washington can help bring attention to this nonsense. A proper interpretation in what is needed. Yes, we want most products that babies and very small children might absorb by mouth that contain Lead to be manufactured with child safety in mind. OHV dealers might be required to include more disclosures, like the ATV Safety Disclosure (that includes free safety training for every new ATV purchaser) that is currently required. But complete elimination of the small off-road vehicles for children will certainly cause more damage and danger to them in the future. It also insinuates that the honest law abiding OHV family is endangering their children, which is definitely not the case. Finally, this could ultimately eliminate the future of our already struggling OHV industry.

Don't just let this happen without telling the bureaucrats that you think this is wrong. See page 11 for more information. After all, the next thing to be eliminated will be your flagpole.

I hope to see you and your family at the CORVA Family Fun Days this month.

PS: Teach your kids, "Don't lick a frozen flagpole - It will stick to your tongue!"

CORVA Land Use Resources and Public Policy Report

• OHV Grants Program

Most of you are aware that without grant funding from the State OHV Division we would have nowhere to ride. The grants fund not only the State OHV Parks like Hollister, Ocotillo Wells, and the Oceano Dunes, but also provide substantial funding for OHV recreation on Forest Service and BLM lands. This year grant applications are done completely online. With the increase in green sticker fees to \$50 every 2 years we have more grant funding available than ever, at least for 2009.

A new timeline for the OHV grant application process has been set.

Activity Date

- Application materials available on website. The second Monday in January
- Preliminary Application filing the first Monday in March
- Public review and comment period: March through April
- Application final filing date the first Monday in May
- Application Results posted first Monday in June



• Johnson Valley

CORVA submitted some excellent comments on the notice of intent to prepare a draft EIS prepared by the Marines. The deadline for comments was January 30, 2009, however it is frequently the case that comments continue to be accepted after the deadline. If you sent comments, thanks!!

We still need people to submit comments on the Notice of Intent to prepare the EIS

It is vitally important that comments be submitted at every step of the process. The draft EIS will probably be published in early 2009 and the comment period will close in 2011. We continue to request that any expansion of the base be toward the East into the Look Sheephole Valley and Cadiz Dunes Wilderness Area.

- BLM TRAVEL MANAGEMENT
- Clear Creek Management Area Management Plan Revision Update

The BLM RAC Off-Highway Vehicle Subcommittee met Jan. 24 at the Tulare County Office of Education. Rick Cooper, Field Manager for BLM Hollister, Jim Keeler, and OHV Director from the BLM State Office and David Christy from BLM.

Rick informed attendees that alternatives for the Clear Creek Management Plan had been drafted. They include a number of possible scenarios for continued use of the area and they have been forwarded to the EPA for review and recommendations. When questioned about the possibility of reopening Clear Creek, Rick responded that given that a closure order is now in place that they are not good. The future of Clear Creek will be determined in the next tow months so please stay tuned for developments.

BLM has indicated that they are willing to work with OHV users to identify other OHV areas. The Subcommittee will come up with criteria for different types of areas that would be suitable for OHV use and the BLM will use planning resources to determine their suitability. The meeting was very productive and all who attended look forward to working on this project.

• BLM Announces Public Meetings for Carrizo Plain National Monument draft EIS

Although the Carrizo Plan is a National Monument and OHV use is mostly prohibited, this designation of 206,000 acres as a non-motorized area established an important precedent. It is worth commenting on this EIS to state that with so much land being set aside for non-motorized use that perhaps something should be reserved for the rest of us...

Public meetings will be held:

- Feb. 24 at the BLM Bakersfield Field Office
- Feb. 25 at the San Luis Obispo Library
- March 7 at the Carrisa Plains School on Hwy 58. The school is located approximately one mile west of Soda Lake road on Hwy 58. The meeting will begin at 10 a.m. and finish at noon.

• BLM's Bakersfield Office Plans Travel Management Workshops

This is BLM's version of Route Designation. These are scoping meetings and are an important opportunity to state your support for inventoried routes in the Bakersfield area. Requests for routes by the public carry a lot of weight, so be sure to send in written comments. CORVA is actively engaged with BLM on the future of OHV recreation in the Central Valley.

• Red Rock State Park General Plan Update

The Red Rock General Plan process is continuing to move forward, but due to state budget problems there has been a slight delay with implementation of the contract with EDAW. Staff have indicated that the next public scoping meeting will be delayed by about one month. The anticipated release of the draft EIS is expected in May of 2009. That will open the formal comment period with a hard deadline of approximately 45 days.

Comments will be accepted up to the time that the alternatives are drafted, although to be assured of consideration comments should be submitted as early as possible. Thanks to all of you who submitted comments by the January 5th deadline. For those who still wish to submit comments you can still send them and please do.

• Forest Service Route Designation

The CORVA Comments Project Team is hard at work on the many Travel Management draft EIS's being published by the Forest Service. This important project will determine where you can ride on California's National Forest for future generations.

Deadlines for comments are: Modoc National Forest - February 11, 2009

Plumas National Forest - March 16 Inyo National Forest - March 30 Sequoia National Forest - March 31



We just received word that the Federal Register is being shut down for review by the Administration. This will delay the publication of draft EIS's for several months. The CORVA Land Resources Team will be watching very closely for developments.

· Omnibus Lands Bill (National Landscape Conservation system) due for House vote soon

Senate bill S. 22, that includes 150 public lands measures including the National Landscape Conservation System (NLCS) Act., and three wilderness proposals is expected to come up for a vote soon. The bill passed the Senate in a history making Sunday vote. The House vote has been delayed by the contentious Economic Stimulus Package. This is a major bill that will have significant effects on OHV recreation. Please send letter of opposition to your Congress people.



Being part of the solution will feel good, hope to see ya on the trail.




Proposed Desert Wilderness Bill Taking Shape

The California Wilderness Coalition has been holding meetings with representatives of US Senator Feinstein to establish new wilderness areas in the California Desert. At this stage we have a chance to provide input that can help determine boundaries and preserve important routes. We have a very experienced and qualified group working on this issue, but they need your help.

The new CWC wilderness proposal includes about 20 new wilderness areas and National Park expansions within Inyo, San Bernardino, Imperial, and San Diego Counties. New wilderness areas proposed by the California Wilderness Coalition within Inyo County include Slate Range and Great Falls Basin north of Trona, Malpais Mesa in the Inyo Mountains around Cerro Gordo extending to the Saline Valley Road, Wild and Scenic River designation for Surprise Canyon, other areas in the northern Panamint Valley, and areas in north Death Valley National Park.

If enacted by Congress, this proposal would eliminate many of the traditional uses such as equestrian endurance rides, mountain biking, and vehicle access for such activities as gem and mineral collecting, spring wildflower viewing, and family backcountry touring and picnic outings will be affected. This proposal would eliminate mineral exploration and new mining in the future. A special thanks is due to Dave Beaumont, John Stewart, Ron Schiller, Wayne Nosala and many others who have worked very hard on a route inventory of the areas.





more and more RV's were coming down the main road, and that our camping area was growing, and by Friday, it had happened. We knew that this was going to be an event to remember. This time instead of the 13 as the first year, we had 104 signups on Friday night!

BUT...


The Dad's need to do a "Guy's only" trip soon. Just think, GOOD rides whenever you want. Eat, drink and sleep whenever you want. No worries..."

HOW TO PROMOTE YOUR SUCCESSFUL CORVA SPONSORED EVENT

A successful OHV event begins with proper planning. Starting at least six months in advance, schedule regular committee meetings; invite all volunteers to participate from the beginning; discuss all aspects relating to the event.

Some items to discuss are site location, permits, insurance requirements, registration forms, volunteer possibilities, vendor donations, T-shirts or other souvenirs, raffles, food preparation and sales, award or other ceremonies, sound systems, vendor follow-up and thank-you letters. Document your process to assist in the next year's event.

The following suggestions will help your event be the success your club wants and needs!

Here's how:

- Keep focused. Don't over work your club with too much for one event. Hold more than one event if necessary.
- Advertise your event in all possible places, including local newspapers & message boards.
- Keep detailed records to document your expenses and results. Make a list of all vendors or contacts including specific information. The next committee will benefit from your experience.
- Give an enthusiastic final report to your club as soon as possible after the event. Discuss what worked and what changes you will want to consider next time.
- Choose a new committee and begin planning early for the next year.


