# **What is CORVA?**

The California Off-Road Vehicle Association (CORVA) is a varied group of outdoor recreationalists who are extremely active in promoting the positive aspects of vehicular access on public lands and protecting that right.

The group is composed of the owners of "Green Sticker" vehicles such as ATV's, motorcycles, 3-wheelers, trail bikes, and dune buggies, as well as "street legal" 4x4 vehicles, dual sport motorcycles, baja and desert racers, and snowmobiles.

We work with land managers for responsible off-highway vehicular access and recreation opportunities. Secondarily, we educate our membership on the constantly changing rules and regulations and promote conservation, clean-up and trail maintenance projects.

We participate in lobbying activities in both Sacramento and Washington DC. We work closely with the State Department of Parks and Recreation providing input to the Off-Highway Motor Vehicle Recreation (OHMVR) program from the users' standpoint.

We provide a valuable resource to land managers in the form of dedicated OHV and OSV enthusiasts who believe in using our public lands responsibly.

We are active at all levels of the land management public process with both the BLM and USFS as well as at the county and local levels. We do this by commenting on many environmental documents on issues that affect us.

We coordinate with other multiple use organizations such as snowmobiles to horse enthusiasts to protect multiple use rights that we ALL share. Only together can we fight the extremists. # Managing Director's Article, Winter 2022 AMY GRANAT

# Off-roaders are undoubtedly the unsung heroes when it comes to land stewardship on federal lands in California.

The OHV community has a long history of supporting adopt—a—trails in all our national forests, and throughout the desert we have groups like Friends of Jawbone and Friends of El Mirage taking responsibility for the lands we enjoy. As recreation enthusiasts, we should be proud of our efforts in areas and trails around California and understand that putting in the hard work is integral to the success of our off—road opportunities and programs. Intuitively, OHV enthusiasts know that efforts undertaken now will pay off in the future, as we develop relationships with land management agencies and prove to them how important roads and trails are to the future of OHV recreation in California.

But why are off-roaders the unsung heroes? Because we have a tendency to keep all our hard work to ourselves. Rarely do we see articles about adopt-atrail successes, or see before-and-after trail pictures in articles or magazines. As a community, we have become accustomed to staying in the background and taking care of our trails, without calling attention to the dedication and hard work it takes to keep a trail maintained. Throughout the state I have seen amazing work undertaken by clubs and individuals with unbelievable efforts largely accomplished on weekends. Most people work a day job, so taking off a weekend to do maintenance on a trail means spending time away from family. As a community, we must acknowledge all these extraordinary on-theground efforts in a meaningful way. Write an article, and put some posts on social media about the work being done to maintain our trails. Let's get the word out!

However, times have evolved, and we have people who are new to off-roading that have joined our large off-road family during the years of the pandemic. They found out what as a community, we've known all along. There is no better way to get away from the pack than by riding or driving on public lands! Many of these folks don't have a history or background with off-road recreation, but just the same they are riding and driving on our roads and trails throughout the state. Whether they are Overlanders, Adventure Bike Riders, new to 4 wheeling or have just discovered the thrill of dirt bike riding, they are now part of our group of off-road enthusiasts. And it's important to all of us that these new users become responsible members of the off-road community, working with the rest of us to protect our motorized roads and trails in California.

Admittedly, this is a monumental goal! It starts with every one of us riding or driving on roads and trail, and setting a positive example. Every time someone sees a 4WD vehicle with a trash bag hanging from the spare tire they will understand the Tread Lightly! principles and the importance of leaving an area in better condition than how it was found. Similarly, everyone riding on the right and staying on the trail sets an example for others who may be less experienced, to follow.

Equally important is for all newcomers to OHV recreation to understand the importance of joining CORVA. CORVA is unique in protecting all off-road opportunities for all types of legal and non-street legal vehicles in California, but there are still many people who don't understand the tremendous role CORVA plays in keeping opportunities open throughout the state. It fascinates me when I hear from people about their favorite roads, trails or

areas. Some may be well known, like the Rubicon Trail, while others may be little used trails, perhaps outside Susanville, in the far northeast area of California. But all of these trails matter to CORVA. because every area around the state is important to OHV enthusiasts. All off-roaders seem to have something important in common – we love to explore! We enjoy riding and driving in new places and want to see the seasons change as we're traveling on a dirt road. Whatever you value most, wherever you travel, CORVA is there for you. Right now CORVA is working on expanding opportunity in the State Parks system. We are seeing a glimmer of hope that might expand opportunities into State Recreation Areas, and the state is actively seeking to create a new State Vehicular Recreation Area to join the other nine. Like everything in government, this could take years to

come to fruition, but we hope some of the easier plans can happen sooner rather than later.

### **Red Rock Canyon**

California State Parks is forming a new management plan for Red Rock Canyon State Park. This is a park by Highway 14 between Jawbone Canyon and Dove Springs. The park is about 25,000 acres and is well loved for its beautiful landscape and routes. The State is accepting comments on the draft management plan now until Dec 16th. The most disturbing aspect of the draft plan is that it eliminates off highway vehicle use in the park. Currently green sticker vehicles are allowed, so this is a problem. I encourage anyone who cares about keeping off-road access there to comment. The draft plan is at:

### **Johnson Valley Shared Use**

29 Palms Marine Corps Base is right next door to Johnson Valley BLM Open OHV area and has the right to close part of the area for up to two 30 day periods per year for military training. The Marines have opened a comment period to allow the public to tell the Marines anything that is bothering them about the shared use area. The shared use area is 56,000 acres, so, if you have anything to tell the Marines about sharing, your chance is now through December 9th. At a recent Desert Advisory Council meeting it was announced that "The Marine Corps plans to utilize the Johnson Valley Shared Use Area in Fiscal Year 2023 in October (10/18–11/1) and February (2/17-2/28), the latter of which occurs during the Presidents' Day Holiday." https://www.29palms. marines.mil/Staff-Offices/Government-and-External-Affairs/Johnson-Valley/

### **Oceano Dunes Update**

# OCEANO DUNES SVRA - STATUS FOR FALL- WINTER 2022-2023

NOTICE (July 22, 2022): The Grand Avenue Entrance Station will be temporarily closed to vehicle traffic due to a planned construction project. Beginning Monday, August 1, the vehicle park entrance will be closed to allow the construction and installation of a new park roadway surface which will assist in reducing sand accumulation along Grand Avenue. This track-out project is estimated to last approximately 6–8 weeks.

During this construction period, Pier Avenue will be the only vehicle park entrance with expected extended vehicle wait time.

This notice has not been updated.

### This Park unit is open.

#### Park Hours:

- Open to daily vehicle traffic between 7 a.m. and 1 hour after sunset.
- The new closing time aligns with other state park coastal units.

### Camping:

- Inventory at Oceano Dunes SVRA has been increased to 150 camping units.
- Camping will be monitored and may incrementally be increased back to 500 units as park operations allow.

#### Visitation:

- State Parks is limiting the total daily allowed number in each park unit to 1,000 "street legal" vehicles and 1,000 "Green Sticker" OHVs.
- Please note: There may be instances where the maximum allowance of vehicles will be met, and no further vehicles will be allowed to enter the beach due to the temporary capacity requirement. Daily visitation information is being posted on our Twitter and Facebook social media accounts.

OHV Rentals: OHV rental businesses are open.

Nighttime Riding: All vehicle activity is prohibited one hour after sunset with exception of visitors camping and traveling to/from their campsites and the park entrance; and emergency vehicles and authorized vehicles.

### Report from the Air Pollution Control District (APCD) Hearing Board Meeting October 14, 2022.

I have been tracking this issue since the last hearing board meeting in June, so I anticipated this would be a key meeting with a major decision being made.

The meeting agenda included a proposed amendment to the SOA and also the Annual Plan of Work, which will be very likely approved by the APCD, with conditions.

Basically, the Hearing Board voted 3/2 to adopt a reduction in the target dust level from 50% or 40.8 %, and to extend the SOA for 2 more years, until 2025. To meet the conditions for approval they will have to do dust mitigation in the plover exclosure area plus close another 96 acres for planting/dust mitigation. Looking at the maps, the additional closures are around the perimeter of areas already undergoing dust mitigation of one type or another, so this shouldn't affect the riding area in a meaningful way.

The APCD, CARB, the SAG and Parks were all in agreement with these proposals.

The APCD and the SAG seem to have finally come to the realization that there will always be blowing dust in a dunes area, and that it is not physically possible for the area to achieve State air quality standards, no matter how much of the area is closed. Apparently they have decided to focus on "nuisance abatement" meaning they want to achieve a dust reduction and reduce dust emissions to pre-OHV use levels. They will use the SAG's 1939 calculated levels as the baseline instead of the 2013 levels they have used up to now. They want to extend the SOA for another 2 years so they can continue to test reduction levels to make sure the mitigation is working, which it seems to be so far.

DPR had little choice but to go along with this.

At one point Gary Willey and Bob Carr reminded everyone that the alternative was to close the area immediately and issue a notice of nuisance and order of abatement, plus the fines of \$1000 per day per Rule 1001, but Mr. Willey at least thought that they should give mitigation a chance to work.

The SVRA will remain open for the time being and a closure and abatement order with fines was avoided. This will also give the legal cases a chance to play out in the court system.

Any day that the ODSVRA avoids closure is a good day.

# Nonprofit's lawsuit currently being decided by court

The Friends of Oceano Dunes reached an agreement with California State Parks to prevent the closure of Oceano Dunes SVRA and Pier Avenue while their case against the California Coastal Commission was being decided by the San Luis Obispo County Superior Court.

On March 18, 2021, the Coastal Commission purported to change the permit for Oceano Dunes SVRA to require:

- (a) closure of the SVRA by 2024,
- (b) closure of the Pier Avenue entrance by July 1, 2022,
- (c) a prohibition against crossing Arroyo Grande Creek immediately when even a trickle of water is present, and
- (d) a host of other interim restrictions on SVRA OHV recreation and camping.

The nonprofit had been negotiating with state parks and the commission to "stay" the March 2021 permit conditions during the litigation. In December 2021 the Friends reached an interim agreement with state parks, and the commission agreed not to oppose the interim agreement in court.

State parks agreed to immediately allow camping and OHV recreation at the Oceano Dunes SVRA, and to stop crossing at the creek only if water levels in the creek reached 12 inches. The Friends and state parks also agreed that Pier Avenue would not be closed on July 1, 2022 but would remain open while the court was deciding the case. Other technical requirements were modified to make them less onerous on OHV recreation and camping while the case is being decided.

### **The Administrative Record**

Following an agreement with the Coastal Commission, an administrative record has finally been prepared. This clears the way for court cases to proceed in the Fall of 2022. The case will undoubtedly continue into the Spring of 2023.

The administrative record includes all the evidence — documents, emails and other records — used by the Coastal Commission to make its decision to close much of the Oceano Dunes to vehicles in March 2021.

After protests from both Friends of Oceano Dunes and EcoLogic Partners, the state agency reduced the cost of preparing the administrative record to \$7,500 split between the organizations and only paid if the Coastal Commission wins the court case.

Each year, Friends of Oceano Dunes spends the majority of its money on "legal fees and lobbyist fees to fight lawsuits by environmental and other groups trying to limit OHV (off-highway vehicles) in the area" of the Oceano Dunes, according to tax returns. In 2020, Friends of Oceano Dunes spent \$322,103, its filing says. About 91% of that was spent on legal fees, while the remainder was spent on travel, conferences or meetings, insurance, outreach and other expenses, according to their tax documents.

We continue to report on what is a discouraging situation, but please keep in mind that there has been more than one order to close the Park, yet despite the many predictions of closure it has remained open for over 40 years. This is mainly due to the highly dedicated and determined legal efforts by the Friends of Oceano Dunes.

### **Summary**

There has been substantial progress in reducing PM 10 dust emissions at the Dunes by implementing dust control measures. This has come at a high cost to

park users, with the loss of over 700 acres of riding area, a reduction of half of the remaining area. The target of a 50% reduction in emissions remains elusive currently but appears to be within reach. Whether or not this will allow the SVRA to remain open remains to be seen.

### **OHV Commission**

The OHV Commission met on November 3 and 4th in Ontario, CA. The OHMVR Commission elected Patricia Urena as Chair of the OHMVR Commission and Kimberlina Whettam as Vice Chair of the Commission.

July 27/28

September 28/29 (perhaps in conjunction with the Off Road Expo)

CORVA representatives had the opportunity to discuss SB 155, a bill that would potentially allow some limited OHV use in State Parks. The bill passed last year in an effort to compensate the OHV Community for the loss of the Alameda–Tesla expansion property.

In addition, CORVA requested an extension of the comment period on the Red Rock State Park General Plan.

The draft Red Rock GP was released Oct 17, 2022. This opens the public comment period that ends December 16, 2022.

The Parks Commission held a tour of the Parks on Thursday Oct 20 followed by a meeting in Lancaster on Oct 21. The Parks Commission will vote to approve the draft General Plan once the public comment period has ended and comments have been reviewed.

CORVA representatives attended the Red Rock tour in person and attended the Commission meeting virtually. It was clear from the tour that the draft plan will not reopen Nightmare Gulch, nor will it allow the use of Green Sticker vehicles in most of the Park. The exception will be ingress and egress via Sierra View Road, but this must be approved by the Parks Commission.

The Red Rock tour was attended by several OHV representatives. Only limited invitations were sent for this event, and it is apparent from reading the draft plan that DPR is closely following the Public Resources Code (PRC) for State Parks. Although Red Rock has traditionally been used by OHV users, it is important to understand that this it is not an SVRA. Red Rock was originally classified as a State Recreation Area in the 1980's, however the Parks Commission changed this designation to a State Park under the Brown administration. The PRC limits OHV use in a State Park to "ingress and egress" and emphasizes resource preservation above recreation in such areas.

State Parks planners indicated that surveys of Red Rock had identified significant natural and cultural resources within the Park, particularly in Nightmare

Gulch, along Black Canyon Road, and in the Cudahy Camp area. Parks planners have added cultural and natural preserves to the draft General Plan because of the presence of resources identified by 2018–2019 surveys.

In Nightmare Gulch, overlapping cultural and natural preserves have been proposed, which would basically close Nightmare Gulch to vehicular travel, which would limited to equestrian and hiking only. OHV use is prohibited within natural and cultural preserves and travel is limited to ingress and egress to and from the Park. Motorized vehicles used in state parks must be street-legal and are confined to areas designated and maintained for normal ingress, egress, and parking. Motorized vehicles are prohibited in preserves.. Vehicle recreation for the challenge or sport of operating a motorized vehicle is listed as an inappropriate use. Street-legal vehicle use on the designated park road system is an allowable use, but an activity of secondary importance.

### **Carnegie SVRA Update**

General Plan Update under preparation for existing Carnegie SVRA. Scoping closed in April 2021. For further information visit the OHMVR planning webpage.

The Off-Highway Motor Vehicle Recreation Division (OHMVR, the Division) previously prepared a General Plan Revision and associated Program EIR for the original Carnegie SVRA and the adjacent 3,100-acre Alameda and Tesla Expansion Area in 2016. While the General Plan Revision was approved and the EIR was certified by the OHMVR Commission in 2016, the Commission rescinded these decisions in 2021 due to several lawsuits. The Department and the Division elected to prepare a standalone General Plan Update for the original Carnegie SVRA.

The Department will conduct a separate planning effort for the Alameda and Tesla Expansion Area to determine a suitable classification and future use of these properties.

This proposed General Plan Update and EIR are limited to the original 1,575-acre Carnegie SVRA and specifically excludes the Expansion Area.

### **State Legislative Update**

CORVA tracked 2 important bills this year as they worked their way through the State Legislature.

### The "Red Sticker" Bill –

SB 894 (Jones) Competition Sticker bill: has passed through Transportation and is referred to the Appropriations Committee and will be heard later in July. Hopefully both bills will pass out of this committee, which is a key step.

The "Red Sticker" –competition bill failed to pass out of committee. We are awaiting further information, but at this point it appears that "non compliant" vehicles will not be registered, will not receive a "sticker' and will not be issued a title and will be provided with a MSO only. These vehicles will not be legal for use on public lands or at SVRAs unless there is new legislation, which seems unlikely.

AB 2152 (Smith) Needles mixed use: This bill would allow the use of green sticker registered vehicles on certain County roads in the Needles area. This bill will also be heard in Appropriations Committee in July. This bill passed out of committee and was signed by the Governor.

### **US Forest Service Report**

Fire restrictions are in place on most national Forests – Check the website of each National Forest you plan to visit for details

Effective May 27, the following restrictions will be in effect:

- No open fires, campfires or charcoal fires will be permitted outside of developed recreation sites or designated Campfire Use Sites, even with a valid California Campfire Permit. Lanterns and portable stoves using gas, jellied petroleum or pressurized liquid fuel will be permitted, but only with a valid California Campfire Permit, which can be obtained free-of-charge at the Ready For Wildfire website. Forest visitors must clear all flammable material for five feet in all directions from their camp stove, have a shovel available, and ensure that a responsible person always attends the stove during use.
- Smoking is prohibited, except within an enclosed vehicle, building, or a designated Campfire Use Site, or while stopped in an area at least three feet in diameter that is barren or cleared of all flammable material.
- Internal combustion engines may be operated only on roads or designated trails. This restriction is in effect year-round. Please make sure your engine is tuned, operating properly, and has an approved spark arrester.
- Fireworks even the "safe and sane" variety are not permitted at any time or in any location within the Forest.

Target shooting is banned in many areas, as is the use of lead ammunition, so check what restrictions apply in your area

### Sequoia and Sierra Forest Plan Revisions

CORVA has been following the proposed Sierra and Sequoia National Forest Plan revisions since 2011. The two national Forests cover nearly 2.5 million acres and have many highly important opportunities for OHV recreation.

CORVA has submitted comments at each step in the process, most recently in 2019.

The Inyo National Forest Plan revision was originally part of this project, but the revised Inyo Forest Plan was adopted in 2019. The Sierra and Sequoia Plan revisions were placed on hold from 2019–2022 because of the Creek Fire (Sierra NF) and the Sequoia Complex Fires.

The Revised draft Forest Plans and related Final Environmental Impact statement and Records of Decision for these plan revisions have been released, and the Forests entered the Objection period on June 14, 2022. Once objections are resolved, the Revised Forest Plans will go into effect.

CORVA will be attending the objection resolution meetings November 15–17,2022.

#### Wilderness additions

The Sierra Forest Plan revision includes no new wilderness areas. The Sequoia Forest Plan revision includes one new recommended wilderness area which is within the boundaries of the Giant Sequoia National Monument.

### Wild and Scenic Rivers

In addition, the revised Forest Plans include a large number of proposed Wild and Scenic Rivers, as well as newly revised Sustainable Recreation Zones.

# 6. HOW ABOUT OUR CLUB'S ANNUAL EVENT WHERE WE INVITE OTHERS?

If your club qualifies as a CORVA Sponsored Club, your event can have outside participants – i.e. non CORVA members. But we encourage CORVA membership. No spectators are allowed at events, only participants.

( Please remember, NO COMPETITION events are covered – No RACING!)

### **Other Questions asked:**

# Does this coverage also include board member liability insurance?

NO – it does not. It is intended to be "event general liability insurance" for the CORVA club offering Certificates of Insurance when required. The Certificate of Insurance is usually needed for the landowner or leaseholder of the property where the event is to be held. (BLM – Forest Service, California State Parks, etc.) However, Directors and Officers Liability Policies are available from our insurance agent. Please request the company information from

your regional representative so that your club may receive a quote.

### Does this cover everyone in my club?

YES – As a CORVA Sponsored Club, all members in good standing of your club are covered under this policy, that's why we request a current membership list when applying for the insurance certificate.

### **Club Requirements:**

The club would be required to provide the following:

- · A membership list of paid-up club members
- An application sheet that would include officers, contacts and chairpersons for events with their contact information
- An approved Safety Program in place for all participants, and an approved waiver signed by all participants for the event
- A check in the amount of \$495.00 designated as their participation fee.
- The club must include CORVA on any permit application needed for their event, since the Certificate of Insurance will actually be issued to CORVA, along with any language required by the landowner/agency for the permit.

The new zones will not affect existing designated roads and trails but will be considered during future Travel Management planning when this occurs at a project level. The main Travel Management project of interest is the Piute Travel Management plan which is already underway. CORVA has been involved in the Piute Plan since inception

#### **Pacific Crest Trail Issues**

The revised plans would add a one mile wide corridor for the Pacific Crest Trail. On the Sierra national Forest this would be entirely within existing wilderness. However, 14 miles of the Pacific Crest Trail corridor on the Sequoia will traverse an area that includes a number of road and OHV trail crossings, some of which are designated routes. This change could very well affect ohv use on these trails.

CORVA has maintained standing to file an objection to the Sierra and Sequoia Plan revisions. The deadline for filing objections is August 15, 2022.

# Biden Administration Provides \$31.1 million to the U.S. Forest Service

In April, the Biden–Harris Administration and the U.S. Department of Agriculture's Forest Service announced \$31.1 million for 15 projects funded through the Collaborative Forest Landscape Restoration Program (CFLRP). The funding aims to reduce the risk of severe wildfires, support local economies, create jobs, and enhance forest and watershed health in eight states with partnership support.

"Programs like this show just how much we can accomplish across a shared landscape when we work together," said Agriculture Secretary Tom Vilsack. "Under President Biden's leadership, the Department of Agriculture is leveraging partnerships and seeking new opportunities to protect our communities, natural resources, and support and create jobs where

they are needed most."

These funds became available through funding from the Bipartisan Infrastructure Law and annual appropriations. The selected projects are in Arkansas, California, Colorado, Missouri, New Mexico, Oklahoma, Oregon, and Washington. Collectively, these landscapes cover 17 million acres — an area larger than the size of West Virginia.

### **BLM Report**

### Members of Congress Petition BLM to Reopen Clear Creek Recreation Area

In early April, Representatives Jimmy Panetta (D-CA-20th) and David Valadao (R-CA-21st) sent a joint letter to the Bureau of Land Management (BLM) California State Director, Karen Mouritsen, urging her to take administrative action to reopen the Clear Creek Recreation Area to managed OHV use. Currently, BLM is undertaking an internal review process to consider the latest scientific information and risk assessments from the EPA.

# The BLM Clear Creek Website indicates that certain areas of the Clear Creek area Management (CCMA) may be legally entered with a permit.

There are two developed campgrounds in the CCMA, Oak Flat and Jade Mill, both with picnic tables, shade structures, fire rings, and pit toilets.

Please note that you may need multiple permits to access areas within the CCMA. Carefully read each permit description to help you decide which permit(s) you may need. The following permits are available for advanced reservation:

Serpentine Area of Critical Environmental Concern (ACEC) Permit: This free permit allows an individual to access the Serpentine ACEC within the Clear Creek Management Area for the duration of one day. Each person, regardless of age, entering the Serpentine ACEC is required to have a permit in their name and



on their person. An individual is allowed a total of five permits per calendar year.

Clear Creek Vehicle Permit: Vehicles entering the Clear Creek Management Area, including the Condon Peak campground and trailhead, are required to have a Clear Creek Vehicle Permit. The permit is \$5 per vehicle and allows the vehicle to enter the Clear Creek Management Area for seven days from the date of entry. Each vehicle must display the permit on its dash while in the Clear Creek Management Area.

Condon Peak All-Terrain Vehicle (ATV) Permit: Every ATV or Utility Terrain Vehicle (UTV) entering Condon Peak's trail network is required to have a permit. The permit cost is \$10 and allows the ATV/UTV driver, age 16 and older, access to the route network at Condon Peak for seven days from the entry date.

# BLM Fire Restrictions have been lifted as of November 2022

### **CURRENT FIRE RESTRICTIONS**

BLM California fire restrictions or temporary public land closures are used to reduce the risk of wildfires and protect the public. Often times these preventative measures focus on human-related activities, such as campfires, off-road driving, equipment use and recreational target shooting, since human-related activities are the number one cause of a wildfires.

Target shooting and other fire restrictions remain in effect for some areas of BLM-managed public lands in California. Find specific restrictions by field office below. Restrictions on target shooting do not prevent hunting with a valid hunting license, as hunting on BLM public lands is managed by the California Department of Fish and Wildlife. Please visit https://wildlife.ca.gov/hunting for more information.

No possession or use of fireworks, including "safe and sane" devices, except with special use permit.

### BLM Issues - WEMO Lawsuit against BLM

CBD recently filed a lawsuit against the West Mojave Route Network Plan.

Many of you who visit the California Desert are familiar with this plan that would designate over 6500 miles of routes in a planning area of over 3 million acres.

The West Mojave Plan, also known as the WEMO plan has been subject to decades of litigation. The plan developed in 2018–19 followed court ordered modifications to the previous plan, including an amendment of the California Desert Conservation Act that originally limited routes of travel to those present in 1980, so this amendment was critically important.

CORVA has long supported the WEMO plan and has previously filed intervenor status when the plan went to court. CORVA has had informal discussions with the BLM about doing this again, and we have been assured that the BLM plans to provide a vigorous defense of the WEMO Route Network Plan which they feel is well constructed, valid and legally defensible.

### West Mojave Route Network Project\*

The Bureau of Land Management released a Record of Decision (ROD) for the West Mojave Route Network Project (WMRNP) that amends the California Desert Conservation Area Plan and approves a travel and transportation route network with nine Travel Management Plans. The route network accesses approximately 3.1 million acres of BLM-managed public lands in the western portion of the Mojave Desert, including parts of San Bernardino, Los Angeles, Riverside, Kern, and Inyo counties.

The route network project provides increased access to recreation areas and points of interests,



connectivity, and consistency across jurisdictional boundaries. It addresses the need for public, authorized and administrative access to and across BLM-managed lands, including motorized, non-motorized and non-mechanized modes of travel. It also eliminates parallel and redundant routes and allows restoration to address use impacts and improve resource conditions.

The entire planning area covers 9.4 million acres of the California Desert Conservation Area, which includes lands managed by federal, private and military entities. The BLM prepared the WMRNP ROD and Approved Land Use Plan Amendment (LUPA)/ Final Supplemental Environment Impact Statement (FSEIS) pursuant to a U.S. District Court Order.

The route network project aligns with Secretarial Orders 3347, 3356 and 3366, increasing outdoor recreational opportunities, advancing conservation stewardship and restoring trust as a good neighbor

through sound travel management of public lands. The selected alternative is consistent with the omnibus lands act, John D. Dingell Jr. Conservation, Management and Recreation Act of 2019 (PL 116-9).

### **Wilderness Legislation Update**

### HR 2546 - Protecting America's Wilderness Act

We expected reintroduction of wilderness legislation that failed to pass the Senate in 2020. As usual the bill was reintroduced into the 117th Congress for 2021–2022. The bill passed the House on a party line vote and was referred to the Senate Energy and Natural Resources Committee, where it has not progressed, despite a determined attempt by environmental groups to have the bill prioritized.

This means the bill will be introduced and considered by the 118th Congress next year.




